

# ANNOUNCEMENT

The Chief Probation Officer of the United States District Court, Northern District of Iowa, intends to procure Treatment Services in the following areas for federal defendants and persons under supervision by means of a Blank Purchase Agreement. Agreements are for a period beginning October 1, 2024, through September 30, 2025, with the option to extend the agreement for an additional four years.

## **Substance Abuse Treatment**

Service Area(s): Cedar Rapids, Dubuque, Waterloo, Mason City, Fort Dodge and their respective surrounding areas.

Required Services: Evaluation/Assessments, Individual Treatment, and Group Treatment.

## **Mental Health Treatment**

Service Area(s): Cedar Rapids, Dubuque, Waterloo, Mason City, Fort Dodge, Sioux City and their respective surrounding areas.

Required Services: Mental Health Assessments; Psychiatric Evaluations, Individual Treatment, and Medication Monitoring.

## **Cognitive Behavioral Treatment**

Service Area(s): Cedar Rapids and their respective surrounding areas.

Required Services: Manualized Cognitive Behavioral Group.

## **Substance Abuse Testing**

Service Area(s): Cedar Rapids, Dubuque, Waterloo, Mason City, Fort Dodge, Sioux City and their respective surrounding areas.

Required Services: Urine Collection/Testing & Reporting; Sweat Patch/Application & Removal.

On or after June 15, 2024, Requests for Proposals (RFPs) will be posted on the Northern District of Iowa United States Probation Office website at <https://www.ianp.uscourts.gov>.

Interested vendors must respond on time, and clearly show that (1) they can provide requested services, (2) treatment services will be provided by certified, licensed professionals with experience in such treatment, and (3) prices of such treatment or testing shall be as low or lower than those charged by the vendor's most favored customer for comparable quantities under similar terms and conditions.
